## Responsibilities

- 1. Leads development and administration of state and federal grants to arts organizations, non-arts organizations, schools, and individuals offering arts education projects
- 2. Designs and executes arts education events, programs, and initiatives such as the Tennessee Arts & Arts Education Conference, Poetry Out Loud State Contest, Tennessee Arts Education Data Project, and Teaching Artist Roster
- 3. Provides technical assistance to organizations, educators, and communities developing arts education programs and projects
- 4. Represents the Commission at local, state, regional, and national meetings
- 5. Acts creatively as part of the Arts Commission team to identify and implement strategies to cultivate the arts for the benefit of all Tennesseans and their communities.
- 6. Supervises Arts Education Special Projects Coordinator
- 7. Serves as a resource for arts disciplines that may include dance, music, opera, theatre, visual arts, craft, design arts, photography, media arts, literature, and folklife/traditional arts
- 8. Generates public support for the arts and arts education
- 9. Prepares records and reports
